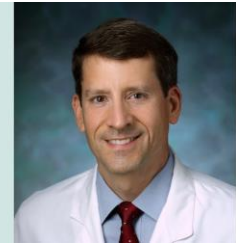

The Collaborative Maintenance Pathway Goes Live

I hope that everyone is enjoying the fall season. My family enjoyed a corn maze and picking pumpkins on a beautiful Sunday afternoon last weekend.

Last Tuesday, October 1, marked the official launch of the ACC's **Collaborative Maintenance Pathway (CMP)**. This event represents the culmination of years of effort on the part of many ACC leaders and staff to develop an alternative to the ABIM's 10-year recertification exam.

As many ACC members will recall, the ABIM rolled out its expanded maintenance of certification (MOC) program in 2014, requiring physicians to earn 100 "MOC points" through online modules every 5 years, including a new controversial Practice Assessment requirement, while continuing to require the 10-year recertification exam, all at substantially increased cost. ACC governors across the country heard from unhappy members and discussed this issue at length at Board of Governors (BOG) meetings. The ACC responded by working with other medical professional societies and the ABIM to significantly **modify MOC requirements**. In addition, the ACC initiated an extended negotiation with ABIM to create an alternative to the 10-year recertification exam, resulting in the announcement of the CMP at ACC.19.

Based on the popular and highly successful ACC Self-Assessment Programs, the CMP combines the educational power of **ACCSAP** with a new online test called a "Performance Assessment" which can be taken at home or in the office. The CMP is designed to promote continuous learning by allowing you to focus on 20% of the field each year, so that over the span of 5 years, your knowledge of the entire field is refreshed. Participation in the CMP entails the following steps:

1. Be currently certified by the ABIM in Cardiovascular Disease and not in an exam grace period.
2. Purchase 5-year subscription to ACCSAP.
3. Spend at least 7 hours engaging in the topic of focus for the year. In 2019, this topic is Arrhythmias.
4. Enroll in the CMP at www.ACC.org/CMPEnroll.
5. Take a Performance Assessment (approximately 60 questions covering Arrhythmias for 2019) at home or in office during one of the 2 weeks offered (November 6-12, 2019 or December 4-10, 2019).
6. Repeat Steps 3 & 5 for the next 4 years. Each year will focus on a different 20% of the content.

In partnership with SCAI, HRS and HFSA, the ACC also plans to offer Collaborative Maintenance Pathways for Interventional Cardiology, Clinical Cardiac Electrophysiology, and Advanced Heart Failure & Transplant Cardiology in 2020, through **CathSAP**, and Heart Failure SAP respectively (Heart Failure SAP will launch in 2020).

The CMP does involve additional cost over the traditional 10-year ABIM recertification exam (\$3000 per 10 years for ACCSAP/CMP versus \$1200 to

register for the 10-year exam, in addition to annual ABIM fee of \$160/year); however, the CMP includes all the educational content of [ACCSAP](#), as well as all the Part II / Medical Knowledge MOC points needed to maintain certification and CME credits to maintain state licensure. It does not require spending a day at a testing center and, for those members who take a Board review course to prepare for the 10-year exam, the CMP may actually be the less expensive option.

The CMP represents the effort of many ACC leaders and staff, as well as hundreds of ACC physician volunteers who are serving as editors, chapter authors, and question-writers. It is a collaborative educational effort that we in the College should be proud of. While the CMP may not be the choice of every member, it provides a real alternative to the 10-year ABIM recertification exam that many members will appreciate.
